

Minutes of a Meeting of Teversham Parish Council
on Monday 8th June 2015 at 7.30pm at Hope Community Church

5 members of the public attended until after the open forum, which concluded at 8.11pm. The Clerk attended and took the minutes.

208. Apologies, Welcome and Introductions

Apologies were accepted from Councillors Amrani, Freeman and Oxford. County Councillor Williams and District Councillor Hunt also sent their apologies.

209. Minutes

The minutes of the last meeting held on 18th May 2015 were agreed and signed by the Chair.

210. Public Forum

Residents came to express their anger and dissatisfaction with the new skate park. They were given copies of the report prepared by the Clerk, which outlined most of their concerns and detailed how the council are trying to deal with litter, anti-social behaviour and noise from the ramps. Complaints were also raised about cars parking in the resident's car park in Sheppard Way and the Clerk was asked to find out if South Cambridgeshire District Council would allow the parish council to put up some signs. The Chairman expressed members disappointment with the noise levels created by the ramps and confirmed that several different options to help reduce the noise are being explored. Residents were encouraged to call the Police to report anti-social behaviour as it is not acceptable and should not be tolerated. Members made it clear that all of the complaints and issues are being taken very seriously and solutions are being discussed and researched.

The discussion also took in that many families have used the park and lots of positive feedback has also been received.

The residents also raised concerns about the grass cutting, the re-seeded grass areas, rubbish in the ditch and the fact that the goal posts are now unusable. Members confirmed that the Clerk is meeting with the land maintenance contractor to discuss the missed grass cut and the quality of the most recent cut and arrangements have been made to re-site the goal posts. The rubbish in the ditch will be reported to South Cambridgeshire District Council.

Members asked the Clerk to ensure that residents are kept informed of progress. The residents then left the meeting.

The Chairman then moved onto item 219 as it concerned the skate park.

219. Borley Way Skate Park

Members discussed the report prepared by the Clerk and it was **RESOLVED** to:

- a. Order x3 new litter bins – 2 for the skate park and x1 for near Christine's bench and arrange for them to be installed as soon as possible. SCDC have also confirmed they will empty the new bins for a fee.
- b. Councillor Martin kindly offered to lend his decibel meter to the Council. Councillor Mackay agreed to carry out some readings to help determine the levels of noise we are dealing with.
- c. Install new signs – wording to be agreed by the Recreation Committee.

- d. It was agreed to work on forming a community led committee to empower the users of the park to look after it and work with residents to reduce litter and anti-social behaviour.
- e. Encourage residents to report ALL incidents of anti-social behaviour to the Police.
- f. Engage with our PCSO to try and encourage visits so the older people using the park late at night are discouraged and move on.
- g. Continue to explore the Acoustic Fencing option.
- h. Continue to explore the option of installing further internal soundproofing into the ramps.
- i. Liaise with SCDC to install residents parking notices in the car park in Sheppard Way.
- j. Work to feedback to residents in Sheppard Way to ensure they are kept up to date on developments and continue to listen to and act upon issues they raise concerning the skate park.

Members thanked the Clerk for her work.

211. Co-option – Two Vacancies

No applications were received. It was **RESOLVED** to advertise the vacancies on the parish noticeboards and place an article in the next edition of the Teversham News.

Councillor Nicholson was elected to serve on the Finance Committee.

Members noted receipt of a letter notifying the council that under the s106 agreement, the developer is required to pay a sum of **£3,104.38** as a financial contribution in lieu of on-site provision of public open space. It was **RESOLVED** to sign the forms.

222. Land Maintenance and Play Areas

Members noted discussed the following issues at length:

- a. **Rats** – residents in Sheppard Way have reported that rats are nesting in the play area (Whitgift Road). It was agreed that members will visit the site and discuss the issue when they meet to view a planning application in Whitgift Road next week.
- b. **Dumping** – The Clerk circulated copies of photographs taken by Councillor Freeman and a lengthy discussion took place regarding the lay-by. Opinions were divided on the value of the lay-by and it was agreed to involve both our District and County Councillors to find a resolution which rids the site of its reputation for a place to dump rubbish. This issue will also be discussed by the Recreation Committee at their next meeting on 15th June 2015.

223. Teversham Local Highways Improvement

There has been no further communication or action on this issue.

224. Highways/Street Lighting

The Clerk confirmed she has asked Nicola Burden when the cats eyes and white lining will be carried out on Airport Way, following the recent re-surfacing work.
