

Minutes of a Meeting of Teversham Parish Council

County Councillor John Williams attended, along with the Clerk who took the minutes. Councillors Amrani and Nicholson left the meeting at 9pm, after item 263.

244. Apologies, Welcome and Introductions

Apologies were accepted from Councillor Freeman. District Councillor Hunt also sent her apologies.

245. Minutes

The minutes of the meeting held on 8th June 2015 were circulated, agreed and signed by the Chair.

246. Public Forum

There were no members of the public present at the meeting. However, Councillor Martin reported he received a complaint about grass growing on the footpath on Fulbourn Road, opposite Ferndale. The same resident also raised an issue about the lack of maintenance of the rose garden on the open space in Marshall's Close. The Clerk agreed to report the issue at Fulbourn Road to CGM and Marshall's Close to District Councillor Hunt as that land is managed by South Cambridgeshire District Council. Councillor Nicholson also reported an issue reported to him with a large tree on the High Street/Sheppard Way. The Clerk believes this is also on District Council land and will investigate.

247. Co-opt to fill two vacancies on the parish council

No applications were received. It was **RESOLVED** to advertise the vacancies on the noticeboards and in the July edition of the Teversham News with the intention to fill them at the next meeting on 7th September 2015.

248. Elect Members to Committees

There were no new appointments or changes.

249. Report from PCSO Julie Hajredini

PCSO Julie Hajredini did not submit a report to the meeting. However, the Clerk gave a verbal report about the ongoing feedback and support that Julie has been giving at Borley Way. Members thanked Julie for her work.

250. Report from County Councillor

County Councillor Williams gave a verbal report regarding the decision not to proceed with changing the central library into an enterprise centre, managed by a private company. He also explained that the consultation on the County boundaries is nearing its closing date and the Boundary Commission will be carrying out a new consultation on the District boundaries. County Councillor Williams also reported on the budget and a short discussion took place.

Queries were raised about the delay in reinstating the white lines on Airport Way and when the footpath along Church Road and Cherry Hinton Road will be resurfaced (slurry coating). County Councillor Williams explained that he will chase this work and Councillor MacInnes confirmed he will try and attend the drop in session hosted by Nicola Burden at Fulbourn on 9th July 2015.

251. Report from District Councillor

The Clerk circulated a report submitted by District Councillor Hunt in her absence. County Councillor Williams answered questions about finance (as he also serves as a District Councillor for the Fulbourn Ward). The Chair reported on issues raised with District Councillor Hunt about the poor state of the bin area at Ferndale and the issues with a resident landscaping land at Lemur Drive/Eland Way. A lengthy discussion took place about hope that the District Council will take action against the residents who have removed shrubs and erected fencing on District land. If they let this go, it sets a dangerous precedent for anyone to take land adjacent to their property. District Councillor Hunt noted in her report that the matter has been passed to the Enforcement Officer. Members concluded that they are very concerned about the District Council's policy of disposing of land and not informing the Parish Council and asked the Clerk to write to the District Council.

252. Clerks Report

The Clerk circulated a report. There were no questions.

253. Proposed Village Hall/Sports Provision

There has been no progress on this project.

254. Hall Farm Caravan Park

The Chairman gave a verbal report following the meeting that took place with Mr Gilbey of Brown & Co, Mr David White, Mr Alan Willis and Mrs Janet Willis. Councillors Kelleway, MacInnes and Mackay attended on behalf of the parish council. A short discussion took place and it was agreed that Councillor Kelleway will go back to the tenants of the caravan park with an update. Members noted that South Cambridgeshire District Council are still to release their decision regarding the planning application S/0987/15/VC – Variation of Condition 1 for Application S/1761/05/F Hall Farm, Church Road, Teversham for Mrs H Symonds. However, whatever the outcome of all of the discussions, members also noted that the park will not be able to continue as it is as it does not meet with current legislation.

255. Borley Way Skate Park

The Clerk circulated a report giving an update on progress of issues raised by the Recreation Committee and residents. It was **RESOLVED** to go ahead with an acoustic assessment. To date, the Clerk has one quotation for £1,150. It was agreed that at least one more quotation should be sought and presented to Councillors Kelleway and Martin to decide which company to appoint. This should be carried out as soon as possible.

Councillor MacInnes kindly agreed to do some further research on the Ambassadors programme.

256. Lemur Drive/Eland Way – Land grab by resident

This issue was discussed under item 251.

257. Cambridgeshire County Council

Agreement for Change of Ownership of Lighting Columns

Members reviewed the documentation submitted and it was **RESOLVED** to sign and return the contract supplied. It was signed by the Chair and the Clerk.

258. Cambridgeshire County Council

Consultation on the revision of Cambridgeshire's Strategy for Flood Risk

262. Teversham Local Highways Improvement

Members noted that the project is nearly completed and should be finished when the white lines are replaced on Airport Way.

263. Highways/Street Lighting

The Chair reported issues with long grass on the verge between the Recreation Ground and Ferndale. The Clerk confirmed she has passed this onto CGM. It was also agreed to ask CGM to tackle the nettles that are spilling over onto the footpath along the High Street.
